The Code of Conduct clarifies the standards of behaviour that are expected of DET staff in the performance of their duties. It gives guidance in areas where staff need to make personal and ethical decisions.

Objectives - statement

The Code of Conduct clarifies the standards of behaviour that are expected of staff of the Department of Education(DoE) in the performance of their duties. It gives guidance in areas where staff need to make personal and ethical decisions.

Audience and applicability

- All Department of Education staff including TAFE NSW and Community and Migrant Education staff and operations.
- The policy does not apply to staff employed by bodies that are only partially funded by DoE.
- The policy applies to members of the Senior Executive Service (SES). SES staff are also to comply with the current *Code of Conduct and Ethics for Public Sector Executives* issued by the Premier's Department.

Context

DoE is committed to the highest standards of conduct in public education, training and administration. To meet this commitment, DoE has issued this single Code of Conduct to cover all departmental sectors and to more closely align staff conduct with the organisational values and ethics that underpin DoE's policies and procedures.
